Subject:- REVISION OF BASIC PAY SCALES, ALLOWANCES AND PENSION OF CIVIL EMPLOYEES (BPS 1-22) OF THE NWFP GOVERNMENT (2005).

Dear Sir,

I am directed to refer to the subject and to state that the Governor N.W.F.P has been pleased to sanction inter alia revision of Daily Allowance admissible to Government Officers/Officials, while being on official duty within the Country. These revised rates were circulated vide Finance Department's letter No.FD(PRC)1-1/2005 dated 9/7/2005 and are effective since then. However, the same revised rates are circulated separately as hereunder for the purpose of easy and quick referencing please:-

REVISED D.A RATES.

BPS	Ordinary Rate per day (Rs.)	Special Rate per day. (Rs.)
1-4	125	200
5-11	155	220
12-16	280	365
17-18	500	640
19-20	625	825
21-22	700	1000

2. Specified stations as notified from time to time are Hyderabad, Karachi, Sukkur, Bahawalpur, Multan, Quetta, Sargodha, Sialkot, Lahore, Gujranwala, Rawalpindi, Islamabad, Faisalabad, Peshawar, Northern Areas, Muzaffarabad & Mirpur AJ&K.

3. Daily allowance will be admissible only for the actual night(s) at the out-station for which daily allowance is claimed. Where night stop is not involved and if absence from headquarters exceeds four hours half daily allowance will be allowed.

4. Government servants upto BPS-1 – 19 may stay in Government Guest Houses, Public Sector Corporations, Rest Houses and Motels/ Hotels (minus five star hotels). They can claim actual room rent charges on production of receipts subject to a maximum of three Daily Allowances in specified stations (i.e localities where special rate of DA is admissible) and one and a half Daily Allowances at non-specified stations (i.e localities where ordinary rate of DA is admissible).


"Provided that such Government servants shall not be required to produce receipt for claiming actual room rent charges for staying in Hotels/Motels".

5. Government servants in BPS-20 and above may stay in hotels and claim room rent charges on production of receipts subject to a maximum of three Daily Allowances for specified stations, and one and half Daily Allowances at non-specified stations. If however, the rooms rent charges are in excess of the maximum ceiling aforementioned, the Government will pay fifty percent of the additional amount. These orders shall take immediate effect.

"Provided that such Government servants shall not be required to produce receipt for claiming actual room rent charges for staying in Hotels/Motels".

"Provided further that in cases where the actual room rent charges are in excess of the maximum ceiling aforementioned, fifty percent of the additional amount will be paid by Government on production of receipt for payment of room charges".





NO.FD(SOSR.II)8-52/2005. In exercise of the powers conferred by section 26 of the North-West Frontier Province Civil Servants Act, 1973 (N.W.F.P Act No XVIII of 1973), the Governor of the North-West Frontier Province is pleased to direct that in the North-West Frontier Province Travelling Allowance Rules, 1980, the following further amendments shall be made, namely:

AMENDMENTS.

In rule 2.36,-

(i) In sub-rule (2), the full stop appearing at the end shall be replaced by a colon and thereafter the following proviso shall be added, namely:

"Provided that such Government servants shall not be required to produce receipt for claiming actual room rent charges for staying in Hotels/Motels;" and

(ii) In sub-rule(3), the following shall be substituted namely;

"(3) Government servants in BPS-20 and above may stay in Government Guest Houses, Public Sector Corporations, Rest Houses and Motels/Hotels and claim actual room rent charges on production of receipt subject to a maximum of three Daily Allowance for specified stations and one and half Daily Allowance at non-specified stations":

Provided that such Government servants shall not be required to produce receipt for claiming actual room rent charges for staying in Hotels/Motels:

"Provided further that in cases where the actual room rent charges are in excess of the maximum ceiling afore mentioned, fifty percent of the additional amount will be paid by Government on production of receipt for payment of room charges".




