1. Advise on the scope, fund allocation, eligible sectors for priority investment under CDLD.
2. Explore the possibility of improving the fiscals pace for expanding CDLD activities into additional districts of Khyber Pakhtunkhwa.
3. Advise on the fund sharing formula amongst the districts.
4. Periodically review the CDLD governance and institutional arrangements, including the eligibility and proposals evaluation criteria, and advise on improvements for efficient and effective attainment of the CDLD policy's objectives.
