**NOTICE INVITING FIRMS FOR PRE-QUALIFICATION FOR SOLARIZATION OF
DRINKING WATER SUPPLY SCHEMES AND SOLAR STREET LIGHTS.**

Director Local Government and Rural Development, merged area is implementing different projects on Solarization of various projects in the merged areas and therefore, intends to pre-qualify firms for current financial year i.e. 2019-20, for which the interested firms are invited to participate in the pre-qualification process. It can be extended to next financial year, if deemed necessary after approval of Competent Authority.

The Application for pre-qualification should accompany the attested documents/Information as per details mentioned in the EOI Documents.

1. Financial position of the last three years including bank statement and audited reports by an external auditor.
2. Last three years Income Tax and Sales Tax returns showing annual turn-overs in the field of Solar business only.
3. Registration with Khyber Pakhtunkhwa Revenue Authority (KPRA).
4. Provide reference of previous years supply and installation of solar based pumps projects and Solar Street Lights complete in all respects to Government Departments, International Non-Government Organizations, Donors projects and UN agencies, with satisfactory performance certificate from concerned agencies.
5. PEC registration for year 2019-20 with at least C-4 category along with specialized codes CE09 EE-04, EE-06, EE11 (Solar Energy), CVs of the engineers registered by the firm with PEC to be provided. CVs of other professional staff working with the firm to be provided.
6. List of Engineers employed by firms along with verifiable evidence of their employment with the firm to be provided.
7. List of equipment should be provided along with proof of ownership. Testing facility (Test Bed) of the solar based system should be made available as per ISO 9906 testing standards.
8. The profile or documents submitted by the firm shall be evaluated as per PEC / KPPRA criteria.
9. EOI documents and detailed evaluation criteria can be obtained from office of the undersigned on written request on payment of Rs.2000/- per set in the shape of call deposit in Favor of Director Local Government, on any working day before the last date of closing. No cash will be accepted.
10. Incomplete, any missing document or conditional application/proposals shall not be entertained.
11. Procuring entity reserve the right to reject one or all the proposals by assigning any cogent reason in light of KPPRA Rules.
12. KPPRA act and rules shall be followed in true letter and spirit.


