- The financial bidding will be online through E-bidding system tender form and BOQ can be filled online and download from the official website of LGE&RDD (<u>www.lgkp.gov.pk</u>) after one day of publishing NIT.
- The contractors quoting their bids up to a limit of 15% below Engineer Estimate shall submit bid security to the extent of 2% of Engineer Estimate only.

- 3. The contractor quoting their bids more than 15% on Engineers Estimate shall submit alongwith their bids an Additional Security to the extent of their bid rates more than 15% below on engineer estimate in the form of percentage.
- 4. In case the bidder quote more than 15% below the Engineer Estimate and the bid is not accompanied by the Additional Security then the bid shall be considered as non-responsive and the 2nd lowest bidder and so on will be considered accordingly.
