

#### Terms & Conditions.

1. The financial bidding will be online through E-bidding system. Tender form and BOQ can be filled online and downloaded from the official website of LGE&RDD ([www.lgkp.gov.pk](http://www.lgkp.gov.pk)) after one day of publishing NIT.
2. The bidders are required to fill Electronic bids online and attach scan copy of Bid Security in shape of original Call Deposit in the name of procuring Entity alongwith (Additional Security if any), and submit hard copy of the same printed electronic bid form to the procuring Entity/Executing Agency. (Assistant Director, LGRD, South Waziristan)
3. Electronic bids and original call deposit's received through fax or by hand will not be acceptable. Sealed bids sent through registered mail/courier service should reach up to the specified time and date as mentioned above.
4. The Eligible bidder must have the relevant codes for the above mentioned works as per Pakistan Engineering Council.
5. The contractor or his representative may be present at time of opening of electronic bids opening.
6. The call deposits i.e Bid Security alongwith (Additional Security if any), for the work/ contract must be prepared after publishing of NIT, before closing time of the Electronic bid apply.
7. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineer Estimate.
8. The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
9. [Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis]2. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
10. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
11. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
12. After commencements of work by the successful bidder, the procuring entity may replace the Additional Security with a bank guarantee of the same amount from the scheduled bank; if the already deposited security is not in the form of bank guarantee.
13. The Additional Security shall be released to the contractor in four installments i.e. 1st installment of 25% to be released upon completion of 25% of the project, 2nd installment of 25% to be released upon completion of 50% of the project, 3rd Installment of 25% to be released upon completion of 75% of the project and the 4th installment of 25% to be released after 100% completion of the project.
14. All previous orders, instructions and regulations issued regarding additional security shall stand superseded.
15. Any Electronic Bidder who provide false, or materially inaccurate or incomplete or do not send information in hard form will be disqualified as per KPPRA Act Section 29(1) read with KPPRA Rule (43). Furthermore, the procuring Entity/Executing Agency will recommend and sent



- cases for debarring/blacklisting and will initiate/ take action in light of approved procedure/ mechanism as per KPPRA Act Section 29(2) read with KPPRA Rule (44).
16. Electronic Bids will remain valid for 90days from the closing date of bids. (As decided by the procuring Entity/ Executing Agency in light of Standard Bidding Documents).
  17. The PEC and KPRA registration (Active tax payer) must be valid for current financial year.
  18. The Centralized Enlisted contractors with C&W department for the current financial year who wants to participate in tending process may approach Directorate General, LG&RDD Peshawar within two days before closing time of electronic apply for uploading their names on the official website i.e (www. lgkp.gov.pk).
  19. All applicable taxes will be recoverable as per directives of the government in vogue.
  20. Any addition made in the term of & conditions in the NIT advertised will be implemented as per KPPRA Rules.
  21. Work Order will be issued subject to release of funds.
  22. The contractors must be registered from KPPRA regular authority.
  23. Unauthorized persons will not be allowed to participate in the tender process.
  24. The rules/ regulations of Govt of Khyber Pakhtunkhwa, issued time to time will be strictly abided.
  25. Any other information / conditions can be obtained from the office of the undersigned on any working day.
  26. The CDR shall be prepared before the closing time of online applies on E-bidding system.
  27. The contractors who offered their bids online but do not send the hard copies or incomplete/ defective documents, will be debarred from tendering process of Directorate General LG & RDD in the future and their case will also be sent to the competent forum for blacklisting.
